## REGULAR MEETING NOTICE

- 1. CALL TO ORDER The Village of Jones Creek Beautification Committee held a regular meeting on Tuesday, January 28<sup>th</sup>, 2020 and the meeting was called to order at 6:30 p.m. by City Secretary/Administrator Kimberly Morris.
- 2. INVOCATION AND PLEDGE OF ALLEGIANCE The invocation was given by Committee Member Debbie Williamson and the pledge was said by all.
- 3. ROLL CALL OF MEMBERS The following members were present: Nicole Hardesty, Tammy Butler, Regina Tidwell, Debbie Williamson, and Brandy Follin.

## 6. NEW BUSINESS

- a. Discuss and Consider Appointing a Chairperson. Mrs. Tammy Butler made a motion to nominate Mrs. Nicole Hardesty as Chairperson for the Jones Creek Beautification Committee. Mrs. Brandy Follin seconded the motion. Mrs. Regina Tidwell, Mrs. Tammy Butler, Mrs. Debbie Williamson, and Mrs. Brandy Follin voted in favor, and Mrs. Nicole Hardesty abstained. Motion carried.
- b. Discuss and Consider Financial Monthly Report. Mrs. Nicole Hardesty made a motion to accept the Financial Monthly Report for January 2020. Mrs. Tammy Butler seconded the motion, all members voted in favor, and motion carried.

- c. Discuss and Consider South Star Bank Authorization Signatures. Mrs. Brandy Follin made a motion to approve Mrs. Nicole Hardesty as an authorized bank signature for the Jones Creek Beautification Bank Account, with a second from Mrs. Tammy Butler. Motion carried after a full favorable vote of the committee.
- d. Discuss and Consider Setting Quarterly Meeting Dates and Times. After a brief discussion by the committee, Mrs. Nicole Hardesty made a motion to hold quarterly meetings, starting in June 2020, on the 1<sup>st</sup> Monday of every quarter at noon. Mrs. Brandy Follin seconded the motion, all members voted in favor, and motion carried.
- e. Discuss and Consider Future Projects, Missions, and Goals. Numerous subjects were discussed amongst the committee including the following: city wide trash pick-up, committee participation in city events, school clean-up day, revitalization of historical markers and city signs, and fundraisers. Mrs. Nicole Hardesty made a motion to schedule a Bake Sale Fundraiser on April 9<sup>th</sup>, 2020 from 8 am until baked goods are sold and also a City Wide Trash Pick-up Day possible on March 28<sup>th</sup>, 2020. Mrs. Brandy Follin seconded the motion, all members were in favor, and motion carried. Mrs. Nicole Hardesty advised the committee a special called meeting on February 18<sup>th</sup>, 2020 at noon needed to be scheduled to finalize events details, all were in agreement.
- f. Discuss and Consider a Food Donation Box. Mrs. Nicole Hardesty made a motion to table the Food Donation Box with a second from Mrs. Tammy Butler. All members voted in favor and motion carried.
