3. **ROLL CALL OF MEMBERS** Anna Galloway, Tammy Butler, Barbara Sloan, Regina Tidwell, Not Present; Nicole Hardesty, Debbie Williamson
4. **BUSINESS OF VISITORS** Discussion with Traci Stowers and her mother Terri went through their confirmed donations for the Trunk or Treat and these to include future donors as well. Everyone thanked them for all of their help with doing this on their own time.
5. **OLD BUSINESS**
  - a. Consider approval or other action regarding the minutes of the regular committee meeting held on May 19, 2022. Anna Galloway motion to approve the minutes of the May 19, 2022 meeting, 2nd Regina Tidwell, all in favor, motion carried.
  - b. Discuss and consider financial statement. Anna Galloway asked if we can earmark certain amounts and limits for funds. Regina Tidwell motion to approve the financial statement, 2nd Anna Galloway, all in favor, motion carried.

  - a. Discuss and consider Spring City Wide Clean up event to be held on April 29, 2023.



- b.
