Take notice that the Board of Adjustments of the Village of Jones Creek, Texas will hold a Public Hearing on Monday, July 15, 2019 at 6:30 p.m. at City Hall located at 7207 Stephen F. Austin Road within the incorporated limits of said Village.

- 1. CALL TO ORDER The Village of Jones Creek Board of Adjustments held a public hearing on Thursday, March 14th, 2019 the meeting was called to order at 6:30 p.m.
- 2. INVOCATION AND PLEDGE OF ALLEGIANCE The invocation was given by Mr. John Rice. The pledge was said by all.
- 3. ROLL CALL OF MEMBERS The following members were present: Brett Robertson, John Rice, and Bill McNutt. Brent Pittman and Dana Chilcote were absent.

4. OLD BUSINESS

- a. Consider approval or other action regarding the minutes of the public hearings held June 11th, 2019. A motion was made by Mr. John Rice and seconded by Mr. Bill McNutt to approve the minutes of June 11th, 2019; all three members were in favor, motion passed
- b. Discuss and Consider Request by David Bell to grant a Variance of Section 155.036 of the Comprehensive Zoning Ordinance of said Village, read, passed and adopted as Ordinance No. 81 on the 21st day of March, 1977, with respect to the following real property located therein: The Board of Adjustments began discussion on the application of a variance to allow an accessory structure to be erected without a main residential structure on the property at 112 Durazno. The Board allowed members of the audience to speak and asked Mr. David Bell questions related to the variance. Due to the extensive amount of time Mr. Bell stated it would take for the main residential structure to be built, Mr. Brett Robertson made a motion to deny the variance, with a second from Mr. Bill McNutt. Mr. Robertson and Mr. McNutt voted in aye, and Mr. John Rice voted nay, and motion carried by a majority vote.
