ORDINANCE NO. 527

AN ORDINANCE OF THE VILLAGE OF JONES CREEK, TEXAS, MAKING CERTAIN FINDINGS OF FACT REGARDING AND CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE ANNUAL GENERAL ELECTION HELD IN AND THROUGHOUT SAID VILLAGE ON THE 1ST DAY OF MAY, A.D. 2021, FOR THE PURPOSE OF ELECTING THREE (3) ALDERMEN, ALL FOR A TERM OF TWO (2) YEARS EACH; PROVIDING FOR RATIFICATION AND CONFIRMATION OF THE ACTION TAKEN BY THIS ORDINANCE BY THE MAYOR OF SAID VILLAGE; PROVIDING AN EFFECTIVE DATE FOR THIS ORDINANCE; AND PROVIDING A METHOD OF PUBLICATION FOR THIS ORDINANCE.

BE IT ORDAINED AND ORDERED, RESPECTIVELY, BY THE BOARD OF ALDERMEN OF THE VILLAGE OF JONES CREEK, TEXAS:

SECTION ONE – SCOPE OF ORDINANCE

This ordinance relates to the Annual General Election called by Ordinance no. 524 of the Village of Jones Creek, Brazoria County, Texas, heretofore read, passed, approved and ratified on the 19th day of January 2021, by the Board of Aldermen and Mayor of said Village ordaining and ordering, respectively, that such election be held in and throughout said Village on the first Saturday in May, 2021, to-wit, the 1st day of May, 2021, for the purpose of electing three (3) Aldermen for terms of two (2) years each.

SECTION TWO – FINDINGS OF FACT REGARDING ELECTION

The Mayor and Board of Aldermen of the Village of Jones Creek, Texas, make the following finds of fact with respect to said election, to-wit:

First, that notice of said election was given in the manner and at the time required by law.

Second, that said election was duly called and held in the manner and at the time required by law, and said Ordinance No. 524, and that only qualified voters were permitted to vote at such election.

Third, that based on the election returns of said election, which are now before the Mayor and Board of Aldermen and which are found to be in due form and order and to have been regularly made as required by law cast a total of 470 votes.

Fourth, that the following named candidates received the number of votes set opposite their names, to-wit:

Fifth, that the following named person (s) received the number of write-in votes set opposite their names, to wit: NONE

SECTION THREE – DECLARING RESULTS OF ELECTION

The Mayor and Board of Aldermen of the Village of Jones Creek, Texas, hereby declare and ordain, respectively, that **AJ Jinkins III, Nicole Hardesty, and Corey R. Thomas** have been duly elected as Aldermen, for the Village of Jones Creek for a two (2) year term each that such persons shall be entitled to said office, upon taking the Constitutional Oath of office required by law, for such term and until his or her successor shall have been duly elected and qualified according to law.

SECTION FOUR – RATIFICATION AND CONFIRMATION BY MAYOR

By signing this ordinance, the undersigned Mayor of the Village hereby ratifies and confirms as his action all matters herein above recited which by law come within his jurisdiction.

SECTION FIVE – EFFECTIVE DATE

This ordinance shall be effective immediately upon its passage and adoption.
