CITY COUNCIL REGULAR MEETING AGENDA

The Board of Alderman of the Village of Jones Creek, Texas will hold a Regular Council Meeting on Tuesday, September 15th, 2020 at the Village Hall located at 7207 Stephen F. Austin Road, beginning at 6:30 p.m. <u>THERE WILL BE NO PUBLIC ACCESS TO THE CITY HALL FOR THE MEETING</u> in order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") and to slow the spread of the Coronavirus (COVID-19). Instead, the Board will conduct the meeting by telephonic conference in accordance with the order of the Office of the Governor issued March 16, 2020. The public will be permitted to offer public comments telephonically as provided by the agenda and as permitted by the presiding officer during the meeting. A recording of the telephonic meeting will be made, and will be available to the public in accordance with the Open Meetings Act upon written request. The matters to be discussed and acted on at the meeting are:

Members of the public may request permission to address the Board. Specific factual information or a recitation of existing policy may be furnished in response to an

inquiry made by a member of the general public but any deliberation, discussion, or decision with respect to any subject about which the inquiry was made shall be limited to a proposal to place such subject on the agenda for a subsequent meeting for which notice is provided in compliance with the Texas Open Meetings Act.

- d. Discuss and consider a three way stop sign at Live Oak Dr. and Arrow Lane.

- a. Public Hearing: Village of Jones Creek, Fiscal Year 2020-2021 Proposed Budget.
- b. Discussion and possible action regarding Ordinance 519: AN ORDINANCE APPROVING AND ADOPTING THE VILLAGE OF JONES CREEK, TEXAS, GENERAL BUDGET FOR THE YEAR 2020-2021; MAKING APPROPRIATIONS FOR THE CITY FOR SUCH YEAR AS REFLECTED IN SAID BUDGET; ESTABLISHING THE PROCEDURE FOR INTRA BUDGET TRANSFERS; AND, CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.
