## SPECIAL CALLED MEETING NOTICE

Take notice that the Board of Alderman of the Village of Jones Creek, Texas will hold a Special Called Meeting on Thursday, September 5<sup>th</sup>, 2019 at the Village Hall located at 7207 Stephen F. Austin Road, within the incorporated limits of said Village beginning at 6:30 p.m., the subject of said meeting being as follows:

1. **CALL TO ORDER** *The Village of Jones Creek Board of Aldermen held a special called meeting on Thursday, September 5<sup>th</sup>, 2019 and the meeting was called to order at 6:30 p.m. by Mayor Pro-tem Glenn Jordan.*
2. **INVOCATION AND PLEDGE OF ALLEGIANCE** *The invocation was given by Alderman Justin Wright and the pledge was said by all.*
3. **ROLL CALL OF MEMBERS** *The following members were present: Alderman and Mayor Pro-tem Glenn Jordan, Alderman Terry Jeffers, Alderman Corey Thomas, Alderwoman Nicole Hardesty and Alderman Justin Wright. Mayor Gordon Schlemmer was absent for medical reasons.*
4. **BUSINESS OF VISITORS** (limited to five minutes per person) *There were no business of visitors.*
