REGULAR MEETING NOTICE April 16th, 2019

Take notice that the Board of Alderman of the Village of Jones Creek, Texas will hold a Regular meeting on Monday, April 16th, 2019 at the Village Hall located at 7207 Stephen F. Austin Road, within the incorporated limits of said Village beginning at 6:30 p.m., the subject of said meeting being as follows:

1. **CALL TO ORDER** *The Village of Jones Creek Board of Aldermen held a regular called meeting on Tuesday, April 16th, 2019 the meeting was called to order at 6:40 p.m. by Mayor Gordon Schlemmer.*
2. **INVOCATION AND PLEDGE OF ALLEGIANCE** *The invocation was given by Brother Brent Pittman of the Jones Creek Baptist Church. The pledge was said by all.*
3. **ROLL CALL OF MEMBERS** *The following members were present: Mayor Gordon Schlemmer, Alderman and Mayor Pro-tem Glenn Jordan, Alderman Terry Jeffers, Alderman AJ Jinkins, and Alderman Mike Chilcote.*
4. **BUSINESS OF VISITORS** (limited to five minutes per person) *Brother Brent Pittman invited residents and council members to Sunday sunrise service at 6:30 am at the Gulf Prairie Cemetery. Mr Dan Croft, President of the Brazoria-Fort Bend Rail District spoke under business of visitors in regards to the proposed railroad. He stated there would be an open meeting for public comment in 6 to 8 weeks to discuss the proposed rail routes. Animal Awareness Day on May 18th from 10 am to 2 pm was announced along with a special called meeting on May 14th to canvass the General Election.*

Members of the public may request permission to address the Board. Specific factual information or a recitation of existing policy may be furnished in response to an inquiry made by a member of the general public but any deliberation, discussion, or decision with respect to any subject about which the inquiry was made shall be limited to a proposal to place such subject on the agenda for a subsequent meeting for which notice is provided in compliance with the Texas Open Meetings.

5. OLD BUSINESS

- a. Consider approval or other action regarding the minutes of the regular council meeting held March 19th, 2019. *A motion was made by Mr. Terry Jeffers and seconded by Mr. Glenn Jordan to approve the minutes of March 19th, 2019; all members were in favor, and motion passed*
- b. Consider Financial, Court, Technology and Building Security, Code Enforcement and other Monthly Reports. *Mr. Mike Chilcote made a motion to approve the March monthly reports, with a second from Mr. AJ Jinkins. All members were in favor and motion carried.*
- c. Discuss and Consider Drainage Issues. *Numerous drainage projects were discussed between Drainage Commissioner Rocky Thomas, Marshal William Tidwell, the council, and the audience.*

6. NEW BUSINESS

- a. Discuss and Consider an Interlocal agreement with the West of the Brazos Drainage District. *Mr. AJ Jinkins made a motion to postpone consideration of an Interlocal with the West of the Brazos Drainage District and a second was heard from Mr. Glenn Jordan. All members were in favor and motion carried.*

- b. Discuss and Consider the Creation of a Keep Jones Creek Beautiful Committee. *Mr. Glenn Jordan made a motion to approve spending \$150 to apply to become an affiliate of Keep Texas Beautiful. Mr. AJ Jinkins seconded the motion, all members were in favor, and motion carried.*


7. FUTURE AGENDA ITEMS
