

Minutes,  
May 15, 2018

The Village of Jones Creek Board of Aldermen held a regular meeting on Tuesday, May 15<sup>th</sup>, 2018 at 6:30 p.m. The following members were present; Mayor Gordon Schlemmer, Terry Jeffers, Glenn Jordan, Rocky Thomas, AJ Jinkins, and Mr. Mike Chilcote.

The invocation was given by Pastor Brent Pittman of the Jones Creek Baptist Church.

The pledge to the flag was said by all.

Marshal Tidwell spoke under business of visitors congratulating City Secretary Kimberly Morris on being awarded The Facts Newspaper Leader under 40 Award. Mr. Bobby Cast addressed council with his continued concern about the water quality from Trent Water in the Jones Creek Terrace. It was also announced that the week of May 14<sup>th</sup> through 18<sup>th</sup> is National Police Week and residents were encouraged to thank their local police force.

The Minutes of April 17<sup>th</sup>, 2018 were accepted as presented after a motion and second were heard from Mr. Terry Jeffers and Mr. Rocky Thomas. All were in favor and motion carried.

Monthly reports were accepted by a motion from Mr. Terry Jeffers, and a second from Mr. AJ Jinkins. All were in agreement, motion carried.

Mayor Gordon Schlemmer, Alderman Glenn Jordan, Alderman Rocky Thomas, and Marshal William Tidwell performed the Statement of Officer and Oaths of Office.

Mr. Glenn Jordan made a motion to appoint two new Deputy Marshal's to the police reserve force. Mr. AJ Jinkins seconded the motion, all were in favor, and motion carried. Mr. Hunter Chase and Mr. Robert Pruett Jr. performed the oaths of office.

Mr. Terry Jeffers made a motion to appoint Mr. Glenn Jordan as Mayor Pro-tem, with a second from Mr. Rocky Thomas. All were in favor and motion carried.

No Action was taken to change bank signatures since Mr. Glenn Jordan was reinstated as Mayor Pro-tem.

Mr. Terry Jeffers made a motion to approve the 2016/2017 Fiscal Audit from Sanderson and Schaffer. Mr. Mike Chilcote seconded the motion, all were in favor, and the motion carried.

Mr. Rocky Thomas made a motion to appoint Beamon Whitton to a one year term expiring on June 2019 as Alternate Municipal Judge. Mr. Glenn Jordan seconded the motion, all members were in favor, and motion carried.

Council was informed that residents have coordinated to host the Jones Creek’s Farmers Market on June 9<sup>th</sup> at the Jones Creek Presbyterian Church. They will be holding it the 2<sup>nd</sup> Saturday of every month. Mr. AJ Jinkins made a motion to postpone indefinitely further discussion of the Farmer’s Market or until the group needed anything further from Council. Mr. Glenn Jordan seconded the motion, all were in favor, and motion carried.

Mrs. Diane Howard approached council asking to purchase the old bank building property on Hwy 36. A motion was made by Mr. Rocky Thomas, with a second from Mr. Mike Chilcote, to begin the process of selling the property. All members were in favor and motion carried.

Council considered contracting for Fire Marshal Inspections. Mr. Rocky Thomas made a motion to use Mr. Chris Motely for fire marshal services until council could consider all options. Mr. Terry Jeffers seconded the motion, all members were in favor, and motion carried.

Mr. Glenn Jordan made a motion to adopt a building fee resolution, with a second from Mr. AJ Jinkins. All members were in favor and motion carried.

Council and residents were advised that the City can only regulate subdivision of property in the Extraterritorial Jurisdiction surround the city limits. No further action was taken.

Current and future drainage projects were discussed. No further action was taken at this time.

Future agenda items are as follows:

- Mowing of City Property
- Heavy Haul after Pick-up
- Amending the Bird Sanctuary Ordinance to include Peacocks

Mr. Rocky Thomas made the motion to adjourn at 7:23 p.m. With a second from Mr. Terry Jeffers, all were in favor, and motion carried.
