Minutes, October 17, 2017

The Village of Jones Creek Board of Aldermen held a regular meeting on Tuesday, October 17th, 2017 at 6:30 p.m. The following members were present; Mayor Gordon Schlemmer, Terry Jeffers, Glenn Jordan, Rocky Thomas, AJ Jinkins, and Mike Chilcote.

The invocation was given by Mayor Gordon Schlemmer.

The pledge to the flag was said by all.

Marshal William Tidwell spoke under business advising council to be aware of drainage projects being discussed by neighboring communities.

The Minutes of September 19th, 2017, and minutes to the Special Called Meeting of September 27th, 2017, were accepted as presented after a motion and second were heard from Mr. Rocky Thomas and Mr. Mike Chilcote. All were in favor and motion carried.

Monthly reports were accepted by a motion from Mr. Terry Jeffers, and a second from Mr. Rocky Thomas. All were in agreement, motion carried.

Mayor Gordon Schlemmer advised council on the determination of ATV/UTV regulations for a municipality. No further action to be taken at this time.

Mr. Glenn Jordan made a motion to adopt an Ordinance regulating Recreational Vehicles during emergency situations. Mr. AJ Jinkins seconded the motion, all were in favor, and motion carried.

Mr. Rocky Thomas expressed his desire to see council adopt an ordinance requiring commercial businesses to have landscaping. Mr. AJ Jinkins made a motion to table the item until further details could be considered. Mr. Glenn Jordan seconded the motion, all members were in favor, and motion carried.

Marshal William Tidwell briefed council on the ongoing efforts to recover from flooding due to Hurricane Harvey. No further action was taken at this time.

Mr. Terry Jeffers made a motion to appoint Mr. Glenn Jordan as representative to HGAC General Assembly and Mr. Mike Chilcote as alternate. Mr. Rocky Thomas seconded the motion, all members were in favor, and motion carried.

Mr. Glenn Jordan made a motion to postpone indefinitely further discussion on selling city owned properties with a second from Mr. AJ Jinkins. All members were in favor, and motion carried.

A discussion was heard on drainage issues. Mr. Mike Chilcote nominated Mr. Rocky Thomas as a council representative to discuss drainage issues with West of the Brazos

Drainage Commissioner Doyle Bennet. Mr. Glenn Jordan seconded the motion, all were in favor, and motion carried.

Future agenda items are as follows:

- Employee Retirement Contribution Increase

Mr. Rocky Thomas made the motion to adjourn at 6:59 p.m. With a second from Mr. Terry Jeffers, all were in favor, and motion carried.
