

Minutes,
December 20th, 2016

The Village of Jones Creek Board of Aldermen held a regular meeting on Tuesday, December 20th, 2016 at 6:30 p.m. The following members were present; Mayor Gordon Schlemmer, Terry Jeffers, Glenn Jordan, Rocky Thomas and David Doyle. Mr. Jack Taylor was absent.

The invocation was given by Bro. Brent Pittman of the Jones Creek Baptist Church.

The pledge to the flag was said by all.

There was no business of visitors.

The Minutes of November 29th, 2016 were accepted as presented after a motion and second were heard from Mr. Terry Jeffers and Mr. David Doyle. All were in favor and motion carried.

Monthly reports were accepted by a motion from Mr. Terry Jeffers, and a second from Mr. David Doyle. All were in agreement, motion carried.

Mayor Gordon Schlemmer informed the board that he is still awaiting the appraisal from Mr. Coleman and will get it to council as soon as he receives it. No action taken at this time.

Mayor Gordon Schlemmer informed council he was still working on getting information regarding building inspections. He stated he hopes to have more information for the next meeting. No action taken at this time.

Mr. Rocky Thomas made a motion to have the City Secretary bring the top five applications for the open positions to city council at next meeting for consideration. Mr. David Doyle seconded the motion, all were in favor, and the motion carried.

Mr. Terry Jeffers made the motion to have Centerpoint replace all the existing street lighting to LED at the direction of the Marshal. Mr. Glenn Jordan seconded the motion, all were in favor, and the motion carried.

After a lengthy explanation from the City Secretary regarding auditing options for the city, Mr. David Doyle made a motion to continue our three-year engagement with Sandersen and Scheffer with a second from Mr. Rocky Thomas. All were in favor, motion carried.

Council considered approving a survey for lots 9, 10, 11, and 12 block 14 of the Jones Creek Terrace. Mr. Rocky Thomas made a motion to approve the survey, with a second from Mr. Glenn Jordan. All were in favor and the motion carried.


Mr. Terry Jeffers made a motion to approve the TML-IEBP rerate notice. Mr. Glenn Jordan seconded the motion, all were in favor, and motion carried.

Mayor Gordon Schlemmer informed council that the storage building has been constructed.


Future agenda items are as follows:
