

Minutes,
October 18th, 2016

The Village of Jones Creek Board of Aldermen held a regular meeting on Tuesday, October 18th, 2016 at 6:30 p.m. The following members were present; Mayor Gordon Schlemmer, Terry Jeffers, Rocky Thomas, Glenn Jordan, Jack Taylor and David Doyle.

The invocation was given by Bro. Brent Pittman of the Jones Creek Baptist Church.

The pledge to the flag was said by all.

Mr. Stephen Perry spoke under business of visitors voicing his concern for the council address some residents and not others during meetings. He also suggested to the board to seek installation of a light at Peach Point and Hwy 36.

The Minutes of September 20th, 2016 were accepted as presented after a motion and second were heard from Mr. Terry Jeffers and Mr. Rocky Thomas. Mr. Jack Taylor abstained and all others were in favor.

Monthly reports were accepted by a motion from Mr. Terry Jeffers, and a second from Mr. Glenn Jordan. All were in agreement, motion carried.

Mayor Gordon Schlemmer informed the board that the cost to appraise the both city properties would be approximately \$2800 to \$3000. Mr. Terry Jeffers made the motion to have the properties appraised with a second from Mr. David Doyle. Four others voted for and Mr. Rocky Thomas was opposed.

Mayor Gordon Schlemmer advised council that the concrete for the storage building being installed at city hall would cost an additional \$2000. No other action was taken at this time.

Mr. Terry Jeffers made the motion to approve an amendment to the Plat of Lots 4 and 5, Block 4 of Peach Point Subdivision Section 1. Mr. Jack Taylor seconded the motion, all were in favor, and the motion carried.

A lengthy discuss was heard regarding mulch material for the playground located adjacent to city hall. Mr. Rocky Thomas made the motion to table this item so that we can get more quotes. Mr. Glenn Jordan seconded the motion, all were in favor, and the motion carried.

Mr. Glenn Jordan made the motion to appoint Mr. Jack Taylor as HGAC representative, with a second from Mr. David Doyle. All were in favor, motion carried. Mr. Jack Taylor made the motion to appoint Mr. Glenn Jordan as an Alternate HGAC Representative. Mr. David Doyle seconded the motion, all were in favor, and the motion carried.

Mr. Jack Taylor made the motion to take no further action regarding lights on Peach Point Rd. Mr. Terry Jeffers seconded the motion, all were in favor, and motion carried.

Future agenda items are as follows:

- Review Speeding Issues on Peach Point Rd.

Mr. Terry Jeffers made the motion to adjourn at 7:00 p.m. With a second from Mr. Rocky Thomas, all were in favor, and motion carried.
