

Minutes,
May 17, 2016

The Village of Jones Creek Board of Aldermen held a regular meeting on Tuesday, May 17, 2016 at 6:30 p.m. The following members were present; Mayor Gordon Schlemmer, Terry Jeffers, Rocky Thomas, Jack Taylor, and Glenn Jordan. Mr. David Doyle was absent due to a funeral.

The invocation was given by Bro. Brent Pittman of the Jones Creek Baptist Church.

The pledge to the flag was said by all.

There was no business of visitors.

The Minutes of April 19th, 2016 were accepted as presented after a motion and second were heard from Mr. Rocky Thomas and Mr. Glenn Jordan. All were in favor.

Monthly reports were accepted by a motion from Mr. Jack Taylor, and a second from Mr. Terry Jeffers. All were in agreement, motion carried.

Mr. Jack Taylor made the motion to approve the Ordinance Canvassing the General Election on May 7th, 2016. Mr. Rocky Thomas seconded the motion, all were in favor, and the motion carried.

City Secretary/Administrator Kimberly Morris performed a coin-toss to break the tie between Scotta Jo Stanley and Glenn Jordan for the Aldermen at Large Seat. Mr. Glenn Jordan won the coin toss.

Statement of Officers, Oaths of Offices, and a Certificate of Election was administered to Mayor Gordon Schlemmer, Alderman Rocky Thomas, Alderman Glenn Jordan, and Marshal William Tidwell.

Mr. Sean Stockard, President and CEO for the Economic Development Alliance for Brazoria County advised the board of the services the Alliance can offer the city. Mr. Jack Taylor made a motion to table joining the Alliance at this time. Mr. Rocky Thomas seconded the motion. All were in favor, motion carried.

Mr. Terry Jeffers made the motion to accept the bid from Home Solution in the amount of \$700 for the installation of gutters on city hall. Mr. Glenn Jordan seconded the motion, and all members were in favor, motion carried.

A motion to not require the registration of garage sales was heard from Mr. Terry Jeffers, with a second from Mr. Rocky Thomas. All were in favor, motion carried.

The council reviewed a resolution to amend this fiscal year's budget. Mr. Terry Jeffers made the motion and Mr. Jack Taylor seconded to accept the amendment. All were in favor, motion carried.

The Council considered additional street lighting. Marshal William Tidwell advised the board that he has identified several areas within the City that need street lighting. Mr. Rocky Thomas made the motion to add an additional two (2) to three (3) street lights. Mr. Glenn Jordan seconded, all voted in favor, and motion carried.

Mayor Gordon Schlemmer advised the board that there are vacant seats on the Zoning Board and the Board of Adjustments. He also instructed that at next month's council meeting members can nominate and vote to appoint to those boards.


