5. **OLD BUSINESS**
 - a. Discuss and approve the minutes from the last Drainage Committee meeting on March 3, 2022. *Motion to approve, Corey Thomas, 2nd Glenn Jordan, all in favor, motion carried.*
 - b. Discuss and consider updates on current drainage projects. *Reviewing of drainage project with Robinhood Lane & outfall plans with Drainage District representative & Rocky Thomas. Change order for E. Stephen F. Austin is not approved since the Project has closed as of January. We have the remainder of the project that has to have 3 quotes. Reach out to Engineering company to verify that quote is still good with Sorrell Construction. Reach out to contractors for bids for E. SFA & Frontier lane project. Live Oak Drive culverts work order sent and waiting for Court for approval. Resent with more detailed work to be completed.*
 - c. Discuss and consider reviewing of problem areas including updates from previous meetings, as well as Citizen raised complaints. *Nelson outfall that was filled in, needs to be dug out. Reach out to see if the Interlocal*

could include opening it back up. In between Nelson ct. and Ivy ct. there is a right away, and to please be aware that maybe a relief ditch can be dug to help with drainage. Culvert near LeCompte Home to clean out and regrade driveway. Glenn Jordan mentioned that The end of Smith St at the end of the road will soon all be taken over by the Wildlife Refuge .Discussion that this was already their property.(Huntington Plantation area. Water crossings near the High Lines would be helpful in that area. Mike Noska, mentioned that the road is only for the High line workers, but the whole area is overgrown. Rocky Thomas mentioned that the Shell road area had water pushing back this way in the rain due to the high grass. We need to look into more low water crossings in this area. Trey is the manager over the Wildlife Refuge; we can reach out to him to see if we can get plans in motion for mowing these areas.

6. **NEW BUSINESS**

- a. Discuss and consider Interlocal agreement project updates. *Interlocal to include Drainage ditch from Robinhood Lane from Veterans memorial. Asked that we create the interlocal for the Drainage District ASAP and signed by the Mayor to proceed. Interlocal agreement created with the Drainage District signed by City Secretary on behalf of Mayor Terry Jeffers to include discussed problem areas with drainage.*
